### **About Our Jury Process:**

Thank you for your interest in Artisans Hand Craft Gallery. We always welcome the opportunity to look at new work for possible exhibition in our store.

Founded in 1978 on a shoestring budget by nineteen craftspeople Artisans Hand now carries the work of over one hundred and twenty-five craftspeople from all over the state of Vermont. Due to our desire for a broad and diverse array of crafts, we look for work with a distinctive style, and of exceptional quality.

### **Our Guidelines for Acceptance:**

High quality craftsmanship, originality of design, creative use of medium, compatibility with the work of other exhibitors, uniqueness, appropriate pricing for our area, marketability and display requirements. We do not accept one-of-a-kind 2D work (paintings, pastels, monoprints, etc.) or dried flowers.

Artisans Hand is a consignment gallery. The craftsman is paid 58% of their monthly retail sales. Greeting cards and a limited number of smaller crafts are purchased wholesale.

### **Jury Procedure:**

The Jury meets on the second Wednesday of the month; there is no jury in the months of December and August. **If you are interested in having your work juried please call our Gallery Director, Sandy Ducharme at (802)223-4948 to make an appointment.**

Work should be delivered no later than the Tuesday prior to your scheduled jury date. The work you bring must be a good representation of what you would like to sell here at Artisans Hand. Depending upon the type of work you do, a minimum of 5 pieces of each category of work is suggested. No slides please! Each piece should be marked with your name and retail price. You must pick up on Thursday or Friday following the jury session. If you wish us to ship work back to you please make sure we have appropriate packaging, enclose a shipping label and return postage.

You will receive notification of the results within one to two weeks of the jury. If your work is accepted you must be prepared to submit work for exhibition within three months of notification. We will expect you to be in a position to maintain a consistent and viable body of work at the gallery.

We like to think of our relationship with the craftsman as a mutual venture. We strive to be sensitive to your needs as a craftsman while at the same time working to run a professional gallery known for its high standards and good service.
